

Dear Parents,

We are cognizant of the financial difficulties that Yeshiva tuition can place on a family and are determined to do our part in helping you to meet your tuition obligation, by providing a work/study scholarship to families which demonstrate financial need.

Students who receive a work/study scholarship will be asked to do a certain job within the Yeshiva on a daily or perhaps weekly basis. These small tasks typically do not take up much time, but they help the Yeshiva to function smoothly. Moreover, they enable the student to feel that he is working for the Yeshiva and not merely receiving a grant.

Based on the experience we have accumulated the past several years, we attach several conditions to our work/study recipients. Please read the conditions and sign below to indicate your acceptance.

- 1) Work/study recipients understand that they will **not be allowed** to return home **during the entire** duration of the Yeshiva year, including the Passover break. Similarly, the parent(s) understand that they **will not be** visiting the student in Israel during the duration of the Yeshiva year. This is true even in the event that the student and/or parent is using **frequent flyer miles** to pay for the ticket, or if a **relative purchases** the ticket for them. In the event of a family simcha or a medical emergency, exceptions can be made, but the recipient must first receive a written waiver from the Yeshiva. **The Yeshiva reserves the right to reduce or rescind the scholarship entirely, in the event that this condition is not followed.**
- 2) Work/study applicants must submit the last **year's** tax returns. (In the case of divorce, both parents should each submit his/her most recent tax return.)
- 3) Work/study applicants should submit a **separate paper detailing any exceptional circumstances.**
- 4) Work/study applicants should **request a specific scholarship amount.** Please keep in mind that the **maximum scholarship we offer is 50% of the total shekel tuition amount.** The applicant may or may not receive the amount requested.
- 5) Work/study recipients agree to be assigned a **specific task within the Yeshiva** and agree to carry out that task promptly and to the best of his ability.
- 6) After being notified of the work/study amount, **US recipients** will be **required to sign up with FACTS** for the remainder of their tuition balance.
- 7) In the event that a student receives a significant scholarship from YU, or any other source, the Yeshiva reserves the right to adjust the scholarship we have given.
- 8) **All work/study requests must be submitted to [Rav Cytrin](#) by June 1<sup>st</sup>.**
- 9) Work/study recipients **must submit a detailed plan** of how they intend to fulfill the remainder of their tuition obligation to the Yeshiva **by July 1, 2018. Students who have not submitted this tuition plan will not be allowed to begin learning at the Yeshiva.**
