Dear Parents,

We are delighted that your son will be joining the Lev HaTorah family to continue his Torah learning and growth.

We are cognizant of the financial difficulties that Yeshiva tuition can place on a family. We are therefore determined to help families that demonstrate financial need meet their tuition obligations. Based on the experience we have accumulated the past several years, we attach several conditions to our scholarship recipients. Please read the conditions and sign below to indicate your acceptance.

1. With the exception of the long Passover break, when you are allowed to fly your son home, **scholarship recipients understand that they will not be allowed to fly out of Israel during the duration of the Yeshiva year.**
2. Students on the Lev LaChayal program will be allowed to fly home prior to their IDF induction, after coordinating the dates for this flight with Rav Dudi.
3. **Similarly, the parent(s) understand and agree that they will not be visiting Israel during the Yeshiva year.** The above stipulations apply even if frequent flyer miles are being used or a third party purchases the ticket(s). **In the event of a first-degree family simcha or a medical emergency, of course the Yeshiva will approve travel home,** provided that the recipient first receives a written waiver from the Yeshiva. **The Yeshiva reserves the right to reduce or rescind the scholarship entirely, in the event that this condition is not followed.**
4. Scholarship applicants must submit the **last year's** tax returns. (In the case of divorce, both parents should each submit his/her most recent tax return.)
5. Scholarship applicants should submit a **separate paper detailing any exceptional circumstances.**
6. Scholarship applicants should **request a specific scholarship amount. Please note that our maximum scholarship is 50% of the tuition amount.** The applicant may or may not receive the amount requested.
7. After being notified of the scholarship amount, American students will be **required to sign up with** FACTS for the remainder of their tuition balance.
8. In the event that a student receives a significant scholarship from any other source, the Yeshiva reserves the right to adjust the scholarship we have given.
9. **July 1, 2025 is the deadline for receiving scholarship requests.**
10. Upon receiving the scholarship, there will still remain a tuition balance. Parents are asked to **submit a detailed plan** of how they intend to fulfill the remainder of their

tuition obligation to the Yeshiva **by July 15, 2025. Students who have not submitted this tuition plan will not be allowed to begin learning at the Yeshiva.**

Lev HaTorah is committed to offering our students a rich program of Torah learning, growth and inspiration.

Our ability to provide this level of financial assistance is based on the generosity of our alumni and donors. In an effort to ensure that future generations of Lev HaTorah talmidim also receive similar scholarships, we humbly request that you and your son undertake an ethical commitment, *bli neder*, to contribute to the Lev HaTorah Scholarship Fund, as soon as your respective financial situations allow.


